- 5. Has a cemetery been contacted? (resource list below)
- 6. Is this a suspected Covid-19 case?
 - a. If they do not wish to answer, just inform that the funeral home will likely ask that question.
- 7. What support is needed for the family? Are their daily needs being met?
 - a. spiritual/emotional→ priest contact, Bethany Bereavement
 - b. health/housing/financial→ possibly other SVDP support
