Covid-19 Funeral Information [updated 5.26.20]

Questions for SVDP Client

1. How are you related to the deceased?
2. Who within your family is taking care of funeral arrangements?
 - a. Do we have their contact information?
3. Has a clergy member been contacted?
 - a. If so, is this St. Mary's or a different religious organization?
 - b. If not, provide St. Mary's priest contact or help research contact information on preferred Annapolis church website.
4. Has a funeral home been contacted? (resource list below)
5. Has a cemetery been contacted? (resource list below)
6. Is this a suspected Covid-19 case?
 - a. If they do not wish to answer, just inform that the funeral home will likely ask that question.
7. What support is needed for the family? Are their daily needs being met?
 - a. spiritual/emotional → priest contact, Bethany Bereavement
 - b. health/housing/financial → possibly other SVDP support
