CORONAVIRUS EMERGENCY SPECIAL ENROLLMENT PERIOD DEADLINE EXTENDED TO JULY 15

More than 43,000 individuals in Maryland have enrolled since mid-March

BALTIMORE, MD – The Maryland Health Benefit Exchange announced today that it has extended the deadline of its Coronavirus Emergency Special Enrollment Period so that uninsured residents will have until July 15 to enroll in health coverage through Maryland Health Connection, the state's health insurance marketplace.

The deadline extension comes as more than 43,000 residents have received coverage during this special enrollment period that began in March with Gov. Larry Hogan's announcement of a State of Emergency in Maryland. Even before this extension, Maryland already offered one of the longest special enrollment periods in the country since the emergency began.

Individuals who enroll in health coverage through Maryland Health Connection today through July 15 will have a coverage start date of July 1.

"Access to health coverage is important every day. However, the coronavirus pandemic has heightened awareness of that need, and we've seen a tremendous response of people enrolling in health insurance. We want to ensure that as many people as possible get the coverage they need," says Michele Eberle, executive director of Maryland Health Benefit Exchange.

While you do not have to be sick to seek coverage, health insurance companies on Maryland Health Connection cover testing, visits relating to testing, and treatment of COVID-19. These consumers will not be billed for a copay, coinsurance or deductible for services to test, diagnose and treat COVID-19.

"If you know someone in your family or community who needs health coverage, urge them to get covered by July 15. Illness or injury can happen to anyone at any time. Getting covered will give you and your family the peace of mind of knowing you've got health coverage," says Michele Eberle, executive director of Maryland Health Benefit Exchange.

An additional special enrollment for Maryland tax filers runs through July 15. The Maryland Easy Enrollment Health Insurance Program gives tax filers the option to share information, like household size and income, with the Maryland Health Benefit Exchange to see if they are eligible for free or low-cost health insurance. Those who check the box on state tax forms (502 and 502B) will receive a letter from Maryland Health Benefit Exchange to let them know if they are eligible for free or low-cost health coverage. To date, nearly 4,000 Marylanders have enrolled in health insurance under this innovative program.

As the state faces high levels of unemployment, many Marylanders are losing health coverage offered by employers. Individuals who lose coverage through their jobs have 60 days from loss of coverage to enroll. If they've missed that deadline, they can get coverage through Maryland Health Connection's Coronavirus Emergency Special Enrollment Period through July 15.

To enroll, visit MarylandHealthConnection.gov. Individuals also can download the free "Enroll MHC" mobile app. Free consumer assistance is available by calling 855-642-8572 from 8 a.m. to 6 p.m. on weekdays.

Help is available in more than 200 languages through the call center, as well as Relay service for the deaf and hard of hearing. Trained navigators and brokers statewide offer free help enrolling by phone. You can find information at MarylandHealthConnection.gov.

Last year, nine out of 10 Marylanders who enrolled through Maryland Health Connection were eligible for free coverage or financial help to lower the cost of their health insurance. This special enrollment period is for private health plans. Those who qualify for Medicaid may enroll any time of year.

SE EXTIENDE HASTA EL 15 DE JULIO EL PERIODO DE INSCRIPCIÓN ESPECIAL DE EMERGENCIA POR CORONAVIRUS

Más de 43,000 residentes se han inscrito desde mediados de marzo

BALTIMORE, MD – Maryland Health Benefit Exchange anunció hoy la extensión de la fecha límite del Periodo de Inscripción Especial de Emergencia por Coronavirus; los residentes no asegurados tendrán hasta el 15 de julio para obtener cobertura de seguro médico a través de Maryland Health Connection, el mercado de seguros médicos del estado.

Más de 43,000 residentes se han conseguido cobertura médica durante este periodo especial de inscripción que comenzó en marzo con el anuncio del Gobernador Larry Hogan del estado de emergencia en Maryland. Incluso antes de esta extensión, Maryland ya había ofrecido uno de los periodos de inscripción especial más largos en el país desde el comienzo de la emergencia.

Los individuos que se inscriban a un programa de seguro médico a través de Maryland Health Connection desde hoy hasta el 15 de julio, tendrán como fecha de inicio de la cobertura el 1 de julio.

“El acceso a una cobertura de salud es importante todos los días. Sin embargo, la pandemia del coronavirus ha aumentado la conciencia de esa necesidad, y vimos una increíble respuesta de la gente que se inscribió en un seguro médico. Nuestra meta es que la mayor cantidad de gente posible obtenga la cobertura que necesita” dijo Michele Eberle, directora ejecutiva de Maryland Health Benefit Exchange.

Si bien no es necesario estar enfermo para buscar cobertura, las compañías de seguro de Maryland Health Connection cubren las pruebas de COVID-19, las visitas relacionadas a las pruebas y el tratamiento. Estos asegurados no tendrán cargos por copagos, coseguros o deducibles por servicios para pruebas, diagnóstico y tratamiento de COVID-19.

“Si conoce a alguien en su familia o comunidad que necesite cobertura médica, aconséjeles que se inscriban antes del 15 de julio. Los accidentes o las enfermedades pueden aparecer en cualquier momento. Tener un seguro le dará a usted y a su familia la tranquilidad de saber que cuentan con cobertura de salud” agregó Michele Eberle, directora ejecutiva de Maryland Health Benefit Exchange.

El periodo especial de inscripción para los declarantes de impuestos está abierto hasta el 15 de julio. El Programa de Seguro Médico de Inscripción Fácil de Maryland ofrece a quienes declaran impuestos la opción de compartir con Maryland Health Benefit Exchange cierta información, como el tamaño de su familia e ingresos, para evaluar si son elegibles para seguro médico gratuito o a bajo costo. Cuando marque la casilla en los formularios de impuestos (502 and 502B), Maryland Health Benefit Exchange enviará al declarante una carta por correo para avisarle si es elegible para cobertura médica gratuita o a bajo costo.

Hasta la fecha, más de 4,000 residentes de Maryland se han inscrito en el seguro bajo este programa innovador.

A medida que el estado enfrenta niveles récord de desempleo, muchos residentes de Maryland están perdiendo la cobertura médica ofrecida por sus empleadores. Las personas que perdieron su cobertura al quedarse sin trabajo tienen hasta 60 días después de perder la cobertura para inscribirse. Si ya pasaron esa fecha, aún pueden obtener cobertura a través del Periodo Especial de Emergencia por Coronavirus de Maryland Health Connection hasta el 15 de julio.

Para inscribirse, visite MarylandHealthConnection.gov/espanol o descargue la aplicación móvil gratuita "Enroll MHC". Hay asistencia gratuita al consumidor llamando al 1-855-642-8572 de 8 a.m. a 6 p.m. de lunes a viernes.

Encontrará asistencia disponible en más de 200 idiomas a través del centro de llamadas, y también están disponibles servicios de relevo para personas sordas y con problemas de audición. Navegadores y agentes capacitados en todo el estado ofrecen ayuda para inscribirse por teléfono. Puede encontrar información en MarylandHealthConnection.gov/espanol.

El año pasado, nueve de cada 10 residentes que se inscribieron a través de Maryland Health Connection fueron elegibles para cobertura gratuita o ayuda financiera para disminuir el costo de su seguro médico. Este periodo especial de inscripción es solo para planes de salud privados. Aquellos que califiquen para Medicaid pueden inscribirse en cualquier momento del año.

1. Medicaid

• Requirements for Medicaid Eligibility

- Maximum Income limits
 - 1 adult - No more than \$1468 a month
 - 2 adults - No more than \$1,983 a month
 - Family of 4 - No more than \$4,100 a month.
- Enrollment period
 - A special Enrollment period is open through June 15, 2020 for those persons newly uninsured as a result of COVID, this does not apply to those who may have had coverage lapse
- Citizenship
 - Enrollees must be U.S. citizens or meet alien status and be a Maryland Resident

 - If the person is not 65, blind, or disabled (receiving SSDI), they need to apply through the Maryland Health Connection.

Medical Coverage for Families - Maryland Childrens' Health Program (MCHP)
Need health insurance for your family? The Medical Assistance for Families/MCHP program provides comprehensive medical coverage to income-eligible families, children and pregnant women through managed care organizations (MCOs).

Health Care for Uninsured Adults (REACH)

The REACH health care program is for uninsured adults ages 19-64. REACH offers County residents low-cost doctor visits, checkups, prescription medicine, lab work and tests, radiology services and dental services. See [REACH \(Residents Access to a Coalition of Health\)](#). Effective January 21, 2020, the REACH Program is at capacity for enrolling new applicants. Please call [410-222-7020](tel:410-222-7020) and leave your name, phone number and the ZIP code of your residence. A REACH representative will call you to schedule an appointment if spaces for new enrollees become available.

What is REACH?

In response to the growing number of uninsured adults in Anne Arundel County, the Anne Arundel County Department of Health and the Anne Arundel County Medical Society have partnered with community doctors and other health care providers to offer low-cost health care services through the REACH Program, (REsidents Access to a Coalition of Health).

Free Breast Exams, Mammograms and Pap Tests for County residents who are 40 and older, uninsured or have insurance that does not cover mammograms or Pap tests, and are income eligible..

You can receive referrals for free breast exams, mammograms and Pap tests through the Anne Arundel County Department of Health's Breast and Cervical Cancer Program. Eligible women receive coupons for free care. A network of highly skilled, private County health care providers honor these coupons.

You may be eligible for the Anne Arundel County Department of Health's FREE exam. For more information, call 410-222-6180.

Prescription Savings Program and save an average of 37 percent on prescription medications, as well as discounts on vision care, hearing care, diabetes care, pet medication and supplies. **The Prescription Savings Program is open to all County residents and has no income requirements or age restrictions.** If you are an Anne Arundel County resident and you applied for insurance through the Maryland Health Connection, but are uninsured currently, call 410-222-4531

3. Maryland Children's Health Insurance Program (MCHP)

Uses Federal and State funds to ensure that all Maryland's children have medical insurance. The program provides full health benefits for children up to age 19, and pregnant women of any age who meet the income guidelines. MCHP provides care through a variety of Managed Care Organizations (MCOs) for:

- Children under age 19, who are not eligible for Medicaid
- Pregnant women of any age
- Whose countable income is at or below 200% of the federal poverty level (or up to 300% of the federal poverty level with a premium)

- Children of employed parents whose employer does not offer family health insurance
(NOTE: Even if you have health insurance, it's best to apply and let the case manager assigned to your application determine your eligibility)

To apply, complete an application and provide the requested information. You may apply online at <https://www.marylandhealthconnection.gov/> or apply by telephone by calling the Maryland Health Benefits Exchange Consolidated Service Center. The toll free number is (855) 642-8572 or TTY (855) 642-8573. You may also apply at your local health department or local department of social services.

You will need:

1. General information about family members (names, birth dates and social security numbers)
2. Proof of income
3. If pregnant, written proof of pregnancy and expected date of delivery signed by your doctor or nurse.

What is the Prescription Savings Program?

The Anne Arundel County Department of Health offers the Prescription Savings Program to all residents of Anne Arundel County through ScriptSave, a company that provides prescription savings programs. Residents signed up for the program will receive a prescription savings card that can be taken to any participating pharmacy to receive immediate savings on prescription medications. All prescription drugs are eligible for savings. The savings card provides additional discounts on a variety of other services including vision care, hearing care, diabetic supplies, lab and chiropractic services, medications for pets and more.

Who can apply?

Any Anne Arundel County resident who wants to save on the cost of prescription medications or supplies can get a card. There is no cost to obtain the savings card, and the entire process takes only minutes to complete over the phone or by visiting the ScriptSave website. See how to apply below.

What are the benefits of the Prescription Savings Program?

- Average prescription savings of 37%, with potential savings of up to 75% (based on 2013 national program savings data)
- Savings for you and your entire household
- No enrollment fee or other monthly fees
- No claim forms or paperwork to complete — just present your card at the pharmacy to receive instant savings
- No income requirements or age restrictions
- A nationwide network of more than 62,000 participating pharmacies, with many local chain and independent pharmacy locations
- Mail order option available for maintenance prescriptions
- Discounts on home medical equipment and supplies
- Network of providers and savings on vision exams, eyewear and contact lenses
- Discounts on hearing exams and supplies
- Discounts on diabetic supplies
- Savings on prescription medications for pets
- Quality customer service from knowledgeable Customer Care Representatives

5. Medicare Buy-In Program

Medicare Buy-In Program also known as **QMB (Qualified Medicare Beneficiary)** and **SLMB (Specified Low-Income Medicare Beneficiary)** is designed to protect low-income Medicare beneficiaries from the costs of Medicare coverage, including out-of-pocket cost sharing expenses (deductibles and co-payments).

- **QMB (Qualified Medicare Beneficiary)** Program serves individuals with modest assets (up to \$7,280 per individual or \$10,930 per couple) with combined incomes that do not

go over 100 percent of the federal poverty level. The State Medicaid program pays their Medicare Part B premiums and cost-sharing amounts.

- **SLMB (Specified Low-Income Medicare Beneficiary)** Program pays only the Part B premium for those with incomes between 100 and 120 percent of poverty with assets up to \$4,000 per individual or \$6,000 per couple.

6. Long Term Care Medical Assistance

Long Term Care Medical Assistance (LTC), is designed to cover the cost of nursing home care for low income individuals who meet eligibility requirements, including a look back at resources in the five years prior to application. Applications for LTC may be filed online at <https://mydhrbenefits.dhr.state.md.us/> or mailed to your local health department or local department of social services. The Bureau of Long Term Care at 346 Frederick Road, Catonsville, MD 21228 covers applications from Baltimore City, Baltimore County, Anne Arundel County, and Prince George's County.

7. Arundel House of Hope Medical Clinic

In Fall of 2011, the Arundel House of Hope opened the first free standing (not hospital affiliated) completely free medical clinic in Anne Arundel County. The clinic will offer services to the County's uninsured through voluntary partnerships with doctors from Baltimore Washington Medical Center and other volunteer physicians from the community. The goal of the clinic is to provide free, comprehensive medical care to those in the most need.

This clinic offers a "safety-net of care" to those who do not have health insurance, have limited health coverage, or do not have access to health services for a variety of others reasons.

The Anne Arundel County Department of Health provides the following dental services:

Anne Arundel Dental Access Program (AADAP)

Provides dental services to the uninsured and the underinsured. Through this

cooperative effort, local dentists provide services at reduced fees (10 percent to 25 percent less). Patients are interviewed for eligibility via application. The Dental Access Program will give eligible patients a choice of two or three participating dentists for treatment. Eligible patients are given a fee reduction card that is valid for one year. Dental Clinic for Patients Under 21

Provides dental services to County residents under age 21 on a sliding fee scale, as well as to residents under age 21 with Medical Assistance or in the Maryland Healthy Smiles Program.

School Education Dental Program

Provides oral health education that introduces good oral hygiene and nutrition habits to school-aged children in Anne Arundel County.

Maternity Patient Program

Provides oral health education, cleanings and dental care at the Department's clinics to eligible maternity patients and to maternity patients who are with the Maryland Healthy Smiles Program. Patients are also educated about the prevention of bottle tooth decay and other oral health concerns for babies. Patients can receive comprehensive dental care and referrals to specialists up until delivery of their baby.

a. Maryland Pharmacy Assistance Program (MPAP) the Primary Adult Care

For lower income residents of Maryland who meet the income and asset guidelines set by the State. The recipient pays only a small co-payment.

One person: Income limit \$900/month

Asset limit \$4,000

Two people: Income limit \$1,041/month

Asset limit \$6,000

State of MD has replaced the "Pharmacy Assistance Program" with "**Primary Adult Care.**" This program provides for free outpatient medical and mental health visits as well as meds. 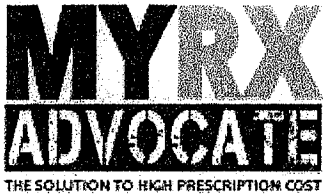

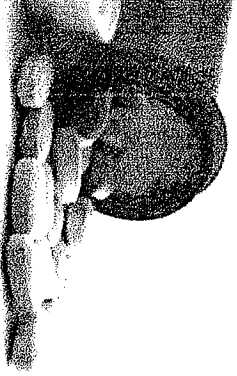

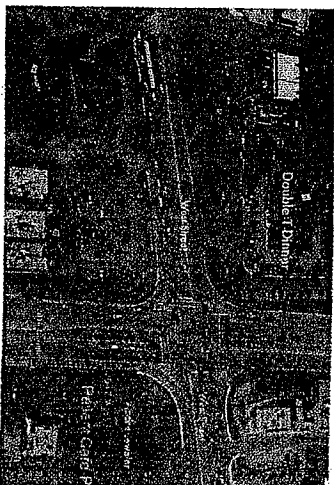
